Entry process for the 2024 Youth Swine Show:

Step #1: Collect all Mandatory Signatures. (Ag Teacher, 4-H Extension Agent & 4-H Leader or YLPA Representative, Parent and Exhibitor). For the 2024 Fair - Signature Page MUST be uploaded, emailed, faxed or mailed by time of corresponding entry due date to qualify for full points for the Achievement Premium program.

Step #2: Go to website at https://fsf.fairwire.com and complete the Online Registration on or before 11:59 pm on October 3, 2023. Entries submitted between October 4th and October 10th will be charged double (\$50) late entry. PLEASE NOTE: When the maximum number of entries is reached (240 exhibitors) – the Online Registration will be closed!!

Step #3: Print the receipt when you have completed the On-Line Registration.

Step #4: If payment was not processed during the Online Registration process, Mail Copy of ShoWorks Receipt and Payment to the Florida State Fair Agribusiness Department. Payment must be received or postmarked on or before October 17th to receive the Entry Points.

Step #5: The Signature Page can be uploaded in the Livestock Entry Documents link on the website under Registration tab. Exhibitors must submit the document to the Ag Office by the corresponding entry due date to be eligible for full entry points. Exhibitors are able to upload, email, fax or mail to finalize entry process.
