Fill out as follows:

- 1. Ear #** - The number or letters permanently tattooed in your animal's left ear. **Letters must be capitalized. If using 1 must be like 1. If using I must be I not i.**
- 2. Breed** - The recognized breed of rabbit by the American Rabbit Breeders Association.
- 3. Variety** - The recognized color of rabbit by the American Rabbit Breeders Association.
- 4. Class** - The class of rabbits in age that your rabbit will be judged in. Circle only the correct age.  
 Jr. = rabbit under 6 months  
 6 - 8 = rabbit between 6-8 months  
 (Examples: Californian, Satin, New Zealand, and French & English Lop)  
 Sr. = rabbit over 6 months of age
- 5. Sex** - The sex of your rabbit showing - Buck (male) or Doe (female).
- 6. Entry fee** - Youth = \$5.00 per rabbit
- 7.** Make sure to sign your entry.
- 8.** Any entry accepted with complete but incorrect information on entry will NOT be changed at time of entry or judging.
