Step #1: Collect all Mandatory Signatures. (Ag Teacher, 4-H Extension Agent & 4-H Leader or YLPA Representative, Parent, and Exhibitor). New for 2024 Fair - Signature Page MUST be uploaded, emailed, faxed, or mailed by the time of the corresponding entry due date to qualify for full points for the Achievement Premium program.

Step #2: Go to the website at https://fsf.fairwire.com and complete the Online Registration on or before 11:59 pm on December 1, 2023. Entries submitted between December 3rd and December 9th will be charged double (\$50) for late entry.

Step #3: Print the receipt when you have completed the Online Registration.

Step #4: If payment was not processed during the Online Registration process, Mail a Copy of the ShoWorks Receipt and Payment to the Florida State Fair Agribusiness Department. Payment must be received or postmarked on or before January 11th to receive the Entry Points.

Step #5: The Signature Page can be uploaded in the Livestock Entry Documents link on the website under the Registration tab. Exhibitors must submit the document to the Ag Office by the corresponding entry due date to be eligible for full entry points.
