**Fill out as follows:**

1. **Ear #** - The number or letters permanently tattooed in your animal's left ear. **Letters must be capitalized. If using 1 must be like 1. If using I must be I not i.**
2. **Breed** - The recognized breed of rabbit by the American Rabbit Breeders Association.
3. **Variety** - The recognized color of rabbit by the American Rabbit Breeders Association.
4. **Class** - The class of rabbits in age that your rabbit will be judged in. Circle only the correct age.
  - Jr. = rabbit under 6 months
  - 6 - 8 = rabbit between 6-8 months  
(Examples: Californian, Satin, New Zealand, and French & English Lop)
  - Sr. = rabbit over 6 months of age
5. **Sex** - The sex of your rabbit showing - Buck (male) or Doe (female).
6. **Entry fee** - Pre-Junior = \$5.00
7. Make sure to sign your entry.
8. Any entry accepted with complete but incorrect information on entry will NOT be changed at time of entry or judging.
