4. NO JOINT OWNERSHIP WILL BE ALLOWED.

5. LEASED ANIMALS ARE NOT ALLOWED.

6 Any exhibitor that is unable to show their own animal must submit a letter to the Agribusiness Office prior to the show for consideration by Show Management in order to participate.

7. Registered Animals that do not have a designated breed show must be shown in the All-Other Youth Beef Cattle Show.

8. Non-registered animals will be shown in the All Other Youth Beef Cattle Show. Non-registered animals showing in the All-Other Youth Beef Cattle Show MUST SUBMIT A COMPLETED RECORD BOOK TO PROVE PROOF OF POSSESSION. PLEASE NOTE: The Fair will be collecting/judging all the Record Books prior to the Fair. Record Books must be postmarked or hand-delivered on or before January 12, 2026. You must turn in a completed record book to be eligible to compete in the Champion of Champions competition. NO RECORD BOOKS WILL BE ACCEPTED AT CHECK-IN. Record books are available on the website.

9. All registered Open Show animals must show in their appropriate Youth breed show if one is offered.

10. Registration papers must be presented at check-in. In the case of papers pending, it will be the responsibility of the exhibitor to provide the Fair with a letter from the breed association stating that the papers have been applied for but have not yet been processed. No papers pending will be accepted without this letter from the association.

11. It is the Fair's intent to allow chapters/clubs to show in the Youth Beef Show to provide an opportunity for participation and learning to students who might otherwise not have the opportunity. Chapter animals must be registered in the name of the chapter. However, separate individuals may be designated to show separate animals by paying a separate entry fee for each animal and specifying the student's name in addition to the chapter name. It is required that the student assigned to show that animal must be responsible for the care and feeding of that animal while at the Fair. That same exhibitor (the one that shows the animal in a class) may enter showman hor each chapter showman.

12. Chapter animals must be shown by a member of that chapter.

13. Any exhibitor from a family with an outstanding balance owed to the Fair will not be eligible to show at the Florida State Fair.

CHAPTERS/CLUBS PLEASE NOTE: Chapters/Clubs must designate student(s) that will enter and compete in all events. That student will be the representative for the Show, Skillathon, Record Book Skills Test, Showmanship, and all other competitions. The age of the student(s) will determine the division of their competition (Junior, Intermediate, or Senior). Chapters/Clubs must designate student(s) by January 12, 2026, hand-delivered, faxed, emailed, or postmarked – Metered Mail will not be considered as a valid or legitimate postmark). If a name is not received by January 12, 2026, the animal(s) will be allowed to show and compete for animal premiums ONLY. The Chapter/Club will not qualify for Achievement Premiums or participation in the Champion of Champion program. All Chapters/ Clubs must have a Federal ID number to enter. The appropriate form is located on the website.

CHAPTER/CLUBS MUST ENTER SEPARATE ONLINE ENTRIES FOR EACH EXHIBITOR

ENTRIES

1. Each Exhibitor may enter and show no more than 2 animals in a single class.

Exhibitors with 2 animals in the same class must have another youth exhibitor with a valid ethics number show the 2nd animal.

2. There is a \$25 entry fee per exhibitor for the Youth Beef Show. Overpayments will not be refunded if \$25.00 or less. Entry Fees are Non-Refundable.

3. Entry Due Date - All entries must be submitted and paid for online on or before December 5, 2025. Hand-delivered or mailed entries WILL NOT be accepted this year. It is the policy of the Florida State Fair to abide by all Rules and Regulations as posted on the Florida State Fair website at www.floridastatefairag.com.

Payment is required at the time of the online entry. The entry fee will be determined by the date entries are submitted online.

The 1st Late Entry Period for entries submitted online between December 6th & 12th, 2025 is subject to space availability and will be charged double (\$50.00) entry fees.

The Final Late Entry Period for entries submitted online between December 13, 2025 & January 12, 2026, is subject to space availability and will be charged double entry fees plus a \$100.00 fee (Youth).

4. TO EXPEDITE THE CHECK-IN PROCESS AT THE FAIR, IT IS <u>MANDATORY</u> THAT COPIES OF REGISTRATION PAPERS BE MAILED, EMAILED, OR FAXED TO THE AGRIBUSINESS OFFICE OR UPLOADED TO THE AGRIBUSINESS WEBSITE PRIOR TO THE FAIR (PENDING PAPERS CAN BE PRESENTED AT CHECK-IN ALONG WITH A

LETTER FROM THE ASSOCIATION – SEE PAGE 2, ELIGIBILITY #10).

5. All entries must be submitted through the Online submission process. All information is available on our website – www.floridastatefairag.com

Please Note: Exhibitors when registering online MUST collect all the Mandatory signatures required on the Signature Page (Ag Teacher, YLPA Representative, or County Extension Agent and 4-H Leader, Parent, and

Exhibitor). The Signature Page is located on page 20 and the website.

Exhibitors must submit the document to the Ag Office by the corresponding entry due date to be eligible for full entry points. The Signature Page can be uploaded in the Livestock Entry Documents link on the website under the Registration tab. Exhibitors are able to upload, email, mail, or fax to finalize the entry process.

- **6.** Fair reserves the right to limit entries based on stall/pen availability. Entries will be accepted in chronological order based on the entry date and timestamp.
- 7. Exhibitors <u>MUST</u> indicate during the online entry process whether or not they plan to keep their animal(s) at a location other than the home place of the exhibitor or the Land Lab for FFA Chapter animals. Failure to provide this information may result in disqualification.
- **8.** Youth exhibitors entering the Open Show must meet all Open Show deadlines and must pay the regular \$25 entry fee, per animal, to enter the Open Show.

9. ALL INFORMATION, SIGNATURES AND ENTRY FEE MUST BE COMPLETED TO BE ACCEPTED AND QUALIFY FOR ACHIEVEMENT POINTS.

12. Only animals entered and shown in the Youth Beef Show and checked by the state veterinarian will be allowed in the barns. No exceptions!!!

ASSISTANCE

- 1. Youth exhibitors are expected to care for, prepare, and show their own animals while on the grounds of the Florida State Fair.
- **2.** Adults (other than parents) or similar unauthorized persons are strictly prohibited from providing direct assistance in the preparation or showing of youth animals while on the grounds of the Florida State Fair.
- **3.** All preparation will be done in a designated area.

4. The Florida State Fair <u>HIGHLY</u> recommends that all clipping be done prior to arrival at the Fair.

- **5.** Exceptions to the above rule must be approved by the committee and be in writing before the Fair.
- **6.** Violations can result in the disqualification of the exhibitor and all premiums, achievement premiums, etc. will be forfeited.

HEALTH REGULATIONS

- 1. All animals must meet health regulations as specified in the Rules for Exhibition as required by the Florida Department of Agriculture & Consumer Services.
- 2. To expedite entry into the Fair, ear tags that correspond to health papers are strongly recommended.

5C-4.0015 Definitions.

For the purposes of this chapter, the definitions in Section 585.01, F.S., and the following shall apply:

- (1) Accredited tuberculosis-free herd. As defined in Rule 5C-3.001, F.A.C.
- (2) Accredited tuberculosis-free state or zone. As defined in Rule 5C-3.001, F.A.C.
- (3) Accredited veterinarian. As defined in Rule 5C-3.001, F.A.C.
- (4) Approved livestock facility. As defined in Rule 5C-3.001, F.A.C.
- (5) Authorized Representative. An employee of the state or federal government, or a licensed veterinarian accredited by the USDA, who is authorized to conduct animal disease control and eradication activities.
- (6) Certified brucellosis-free state or area. As defined in Rule 5C-3.001, F.A.C.
- (7) Certified brucellosis-free herd. As defined in Rule 5C-3.001, F.A.C.
- (8) Classified brucellosis-Class A state or area. As defined in Rule 5C-3.001, F.A.C.
- (9) Department. As defined in Rule 5C-3.001, F.A.C.
- (10) Electronic Official Certificates of Veterinary Inspection (ECVI). An electronic certificate provided by USDA Veterinary Services Process Streamlining System or a third-party vendor approved by the United States Animal Health Association (USAHA) ECVI Data Standards Subcommittee and issued by licensed and accredited veterinarians in animal's state of origin.
- (11) Exhibition. Any fair allowing the displaying or presenting livestock, including poultry, to the general public for an animal exhibit or animal show.
- (12) Fair(s). Annual public fair as defined in F.S. 616.001, that exhibits domestic animals.
- (13) Group. One or more Animals maintained on the same premises or in contact with one another.
- (14) Isolation. Separation of individual Animals by a physical barrier in a manner that assures one Animal does not have access to the body, excrement, or discharges of another Animal; does not share a building with a common ventilation system; and is not within ten feet of another Animal.
- (15) Market class. An exhibition class consisting of finished fed animals.
- (16) Official certificate of veterinary inspection (OCVI). As defined in Rule 5C-3.001, F.A.C.
- (17) Official individual identification. As defined in Rule 5C-3.001, F.A.C.
- (18) Official test. A test conducted by a licensed and accredited veterinarian with method approved by Department rules for the specific disease and animal species. (19) Owner. The owner of the animal or herd or the owner's authorized agent.
- (20) Pseudorabies. A contagious, infectious herpesvirus, causing communicable disease of livestock and other animals also known as Aujeszky's disease or mad itch.
- (21) Recognized slaughtering establishment. As defined in Rule 5C-3.001, F.A.C.
- (22) Swine brucellosis. An infectious bacterial disease caused by Brucella suis (B. suis) biovars 1 or 3, most

frequently affecting swine but able to cause disease in other animals and humans.

(23) Terminal swine show. An exhibition market class consisting of swine that are isolated and housed separately from all other animals and designated for slaughter only channels. (24) Validated brucellosis-free herd, as defined in 9 CFR §78.1 (JAN 2024). This definition of validated brucellosis-free herd is hereby incorporated by reference and available online at http://www.flrules.org/Gateway/reference.asp?No=Ref-

5C-4.0017 General Requirements, Exemptions and Limitations.

- (1) OCVI Required. Animals presented for exhibition purposes in Florida, unless specifically exempted, must be accompanied by an OCVI.
- (a) The OCVI must be complete including the breed, sex, and registration number and, if applicable, the official individual identification of each animal.
- (b) Results of a specific test requirement or herd accreditation, certification or validation number for each animal must be recorded on the OCVI with the date of the test or herd accreditation, certification or validation.
- (2) Expiration of Required OCVI.
- (a) For Florida-origin animals, an OCVI is valid for 90 days from the date of issue; or until the expiration date of any required tests, whichever is the earliest date.
- (b) For animals imported into Florida for exhibition purposes only, the OCVI is valid for 30 days.
- (3) Inspection. Prior to immediate acceptance at an exhibition, all animals presented for exhibition must be made available for inspection by an authorized representative for:
- (a) The required Official Individual Identification of the Animal; and
- (b) Clinical signs of disease including, but not limited to: caseous lymphadenitis, blisters/ulcers around the mouth, nostrils, coronary band, pinkeye, pox, scabies, lice, ringworm, atrophic rhinitis, or multiple warts that are clearly visible; and (c) Evidence of compliance with Animal tests and OCVI requirements, where required.
- (4) Animals Rejected for Exhibition.
- (a) Any Animal in noncompliance with Animal tests and OCVI requirements, or
- (b) Any Animal not meeting the Official Individual Identification requirements, or
- (c) Any animal which is suspected of having or showing clinical signs of dangerous transmissible, contagious or infectious disease on visual inspection, or any animal which is known to be exposed to such diseases must be:
- 1. Immediately withdrawn from exhibition and returned to the place of origin, or
- 2. Examined at the owner's expense, by a Florida-licensed accredited veterinarian who certifies by a signed, written statement, that the animal is free of dangerous transmissible, contagious or infectious diseases and pests. The accredited veterinarian's examination must take place within 24 hours of the initial inspection by the authorized representative.

5C-4.002 Cattle or Bison.

- (1) OCVI Required.
- (a) Florida-origin cattle or bison moved for exhibition must be accompanied by an OCVI dated not more than 90 days prior to exhibition.
- (b) Cattle or bison imported from other states for exhibition must be accompanied by an OCVI dated not more than 30 days prior to exhibition.
- (2) Official Identification Required. All cattle or bison entered for exhibition purposes, including market class animals, must have an official individual identification. If the breed registry and brand or tattoo are used to complete the identification requirements, then the breed registry number and brand or tattoo must be listed on the OCVI accompanying the animal to exhibition.
- (3) Testing Requirements.
- (a) Tuberculosis.
- 1. Florida-origin cattle or bison may be entered for exhibition without a tuberculin test.
- 2. Dairy Cattle. Dairy cattle imported into Florida, may be entered for exhibition provided they have: a. a negative caudal fold tuberculin skin test within 60 days prior to the date of the exhibition, or; b. originate from an accredited tuberculosis-free herd in an accredited tuberculosis-free state or zone.
- 3. Beef Cattle. Beef cattle or bison imported into Florida may be entered for exhibition provided they have: a. a negative caudal fold tuberculin skin test within 60 days prior to the date of the exhibition or; b. originate from an accredited tuberculosis-free herd or state.
- (b) Brucellosis.
- 1. Test Required. Cattle or bison, six (6) months of age or older, must have evidence of a negative brucellosis test within 30 days prior to the date of exhibition.
- 2. Exemption from Required Brucellosis Test.
- a. Steers and spayed heifers; and
- b. Cattle or bison originating from,
- (I) a certified brucellosis-free herd. The OCVI must show the certified herd number and the date of the last herd certification test, or;
- (II) a classified brucellosis-free state or area, or;
- (III) Cattle or bison from non-quarantined herds originating from a classified brucellosis-Class A state or area provided that the cattle are under 18 months of age.

GENERAL

- 1. Please Note: Due to health and safety issues, no cooking will be allowed in the barns; food and drink should not be consumed in animal areas; and exhibitors should wash their hands after handling animals.
- 2. Feed, care, and management of animals will be the responsibility of the exhibitor. Sawdust will be provided for bedding. Failure to maintain animals and exhibit to acceptable standards and/or failure to cooperate with

Fair Officials may result in premium forfeiture and immediate dismissal from the Fairgrounds.

- **3.** Exhibitors must show their own animal unless prior approval has been received from show management.
- 4. It is the exhibitor's responsibility to get in the show ring on time. PA system is a courtesy ONLY. Exhibitors are expected to be on time for their classes.
- 5. Grooming Chute Permit: There will be a \$25.00 fee for each grooming chute for exhibitors showing less than 8 animals. A COMPLIMENTARY PERMIT WILL BE GIVEN TO BREEDERS, CLUBS, CHAPTERS WITH 8 OR MORE ANIMALS. Additional permits may be purchased for \$25.00. (See form on Website). All grooming chutes must have a Florida State Fair permit which must be paid for with an entry fee. Grooming chutes must be confined to areas designated by the superintendent.
- **6.** At the discretion of the Livestock Superintendent, exhibitors may be instructed to double-tie their animals. It is recommended that all youth cattle be double-tied with a neck rope.
- 7. Automatic water systems in the cattle tie area (barn) must be approved by the Livestock Superintendent. No nails, screws, or other fasteners are to be used on the wooded portion of the tie panels.
- **8.** Animals are restricted to designated areas of the Fairgrounds and must not be taken from designated areas. Violators are liable for any damage incurred by the owner or animals.
- **9.** Any person who violates any of the general rules or special rules as posted in this Premium List will forfeit all the privileges and premiums won.
- 10. The physical condition of an entrant, which the appropriate committee considers to be a problem for that entrant to participate in the show, may result in the committee not accepting an entry or not allowing that entrant to participate in the show.
- 11. NO DOGS ARE ALLOWED INSIDE THE BARNS.
- 12. Smoking is not permitted in the barns.
- 13. The use of alcohol is prohibited in barns and livestock areas
- **14.** NO Chairs are allowed in the animal walkways.
- 15. No Chairs are allowed in the Make-Up / Staging Area.

LIABILITY FOR LOSS OR THEFT

- 1. The owner or custodian of the property of any kind brought to the Fairgrounds, either for exhibit or for other purposes, assumes as a condition of its admission to the grounds all risk and/or responsibility for its loss, damage, or theft.
- 2. The Fair, its officers, and its employees cannot and will not accept responsibility and liability for any damage or injury resulting from theft, fire, the elements, accidents, or other conditions or causes; whether to exhibits, property of exhibitor, vehicles on the grounds and articles left therein or any other property of any nature whatsoever.

ARRIVAL

1. Youth Beef animals will arrive per the schedule on the first page.

2. EARLY ARRIVALS: Due to the lack of space during the Fair, early arrivals will not be permitted except in cases where the scheduled arrival time presents a hardship due to travel time, etc. In such situations, a written request must be submitted to the Livestock Office by January 12th. Requests can be emailed to

- Shayla.Ashmore@FloridaStateFair.com. Exhibitors will be notified by February 1st if the request has been approved.
- 3. Exhibitors arriving for the 1^{st} set of shows with cattle for the 2^{nd} group or the 2^{nd} set of shows with cattle for the 3^{rd} group must also follow the Early Arrival procedures stated above.
- **4.** Any cattle arriving late due to conflict with other shows MUST have pre-approval.
- 5. All exhibitors must check in with the Livestock Office personnel by the time indicated on arrival day or they will be considered a "NO SHOW" and will be deleted from the show. Any Pending Registration Papers will be verified at this time.
- **6.** All animals will be received through the Livestock Gate at the Orient Road entrance gate.
- 7. All trailers will be parked in a remote location adjacent to or near the Fairgrounds.
- **8.** Any animals arriving late due to an emergency must call the Livestock Office at (813) 627-4229.

ADMISSION

- 1. Each exhibitor will be issued three (3) armbands for the duration of the show. These are intended for use by exhibitors and parents. The exception will be made when more than one exhibitor is from the same family. Any additional exhibitors from the same family will be issued 1 armband.
- 2. Armbands will be picked up at check-in. Additional armbands <u>CANNOT</u> be purchased. Single-day admission tickets can be bought in advance at discount prices. See the Advance Ticket Form on the website for details. Tickets will be for sale at the gate.
- 3. Vehicle/Trailer Parking Passes: All Trailers will be parked in the designated areas within the interior of the grounds. Exhibitors will receive a Vehicle Pass for the duration of the show to be able to park in the Ag Lot outside of Gate 3. Only vehicles with the appropriate tags are permitted in this area.

 4. Each passenger must have an armband or admission
- pass.

 5. Livestock Gate Drop-Offs Times (This is in addition to arrival): Vehicles will be allowed to enter through the Livestock Gate between the hours of 6 am to 10 am and 3 pm to 6 pm to drop-off needed feed and/or supplies. After
- pm to 6 pm to drop-off needed feed and/or supplies. After unloading supplies, vehicles will proceed to the Ag Lot for parking.
- Parking Map and Detailed Instructions will be posted on the Agribusiness Website prior to the Fair.
- 7. Reserved parking is provided, and exhibitors must park in the assigned Ag Lot or your vehicle will be subject to towing.
- 8. Champion of Champion Lot: Limited Parking Spaces can be purchased by Exhibitors within the interior of the grounds. All information will be posted on the FSF Agribusiness website. Spaces will open for purchase on January 1, 2026. All proceeds will go towards the Youth participating in the Champion of Champions program

FEEDING AND BEDDING

- 1. All cattle will be bedded on sawdust only. No bedding hay allowed
- 2. Feed and water pails must be provided by the exhibitor.
- 3. All cattle must be double tied with both halter lead and neck rope. The proper procedure for this is:

4. All exhibitors of livestock will be required to maintain their exhibit space in a clean, sanitary condition by removal of any filth and/or litter, and placement in designated pickup areas. The sanitation department of the Fair will remove refuse from designated pick-up areas only.

JUDGING

- 1. Judging will be per the schedule on the first page.
- 2. Judging will begin with the Showmanship Class.
- 3. A show ring preparation policy is being implemented for the youth show and showmanship. NO GROOMING MATERIAL IS ALLOWED ON THE ANIMAL. All animals must be washed cleaned and dried without the use of ANY grooming material/aids (BLOW & GO). The definition of Blow & Go is strictly soap and water and nothing else. The use of a brush and/or scotch comb is encouraged. Animals may be checked prior to entering the make-up area (TECO Arena). Animals that fail the check will be refused entry into the arena.
- 4. Grand & Reserve Champion animals may be subject to be checked at the discretion of the Fair management.

 5. ANIMALS THAT ARE UNMANAGEABLE MAYBE EXCUSED FROM THE SHOW RING AT THE DISCRETION OF THE YOUTH BEEF SUPERINTENDENT. ANIMALS THAT GET LOOSE FROM AN EXHIBITOR AFTER THE SECOND TIME WILL BE EXCUSED FROM THE RING.
- **6.** Any animal receiving 1st Place or 2nd place can qualify for a champion.
- 7. Judging will be based on the American System of Judging 8. Judges will not award premiums to any article, product, or animal that is not deserving. It must be judged individually worthy.
- **9.** The decision of the judge shall be final, and no appeal will be considered except in cases of written protest (see General Disputes Policy)
- 10. Any exhibitor who interferes with the judging will be promptly excluded from the competition if after judging, the premiums awarded will be withheld.
- 11. All animals must enter the show ring and be evaluated by the judge in order to receive premiums.

GENERAL DISPUTES POLICY

With respect to any disputes which may occur with respect to an exhibitor at the show, such disputes shall be handled by the appropriate Livestock Committee (the "Committee") in accordance with the following:

1. An exhibitor may file a protest with respect to another exhibitor for violation of the rules and regulations of the Committee and/or the International Association of Fairs and Expositions (IAFE) National Code of Show Ring Ethics by submitting a written protest (a "Protest") on a form (the "Protest Form") which will be available at the Agribusiness Department. The Protest must include the exact basis, cause, and description of the dispute, the name of the protesting exhibitor, the name of the exhibitor being protested, and any materials in support of the Protest as well as any other matters which may be required in the Protest Form and shall be accompanied by payment of \$50 which shall be refunded only if the Protest is sustained by the Committee. The Protest Form must be signed by the exhibitor (as the protesting exhibitor), and if the exhibitor is a minor, the Protest Form must also be signed by the exhibitor's guardian or parent, unless the parent or guardian is not available under circumstances that warrant, as determined by the Agribusiness Department in its sole discretion. Failure to

properly sign the Protest Form shall deem the Protest Form incomplete and nullity, and in such event, the Protest will not be considered. Any Protest must be submitted (and received by the Agribusiness Department) at least two (2) hours prior to the time that the show is scheduled to occur in order to be considered prior to the show. If a Protest is submitted less than two (2) hours prior to the time that the show is scheduled to occur ("a "Late Submittal"), then the Committee will handle the Protest after the show in accordance with its rules and regulations and the IAFE National Code of Show Ring Ethics, but the Late Submittal shall not affect the award of ribbons for the show. In order to minimize disruption to the show, an exhibitor who intends to file a Protest should do so at the earliest feasible time. In any event, a Protest must be filed with the Agribusiness Department prior to the scheduled release hour for the protested exhibitor's animal in order to be considered.

2. The Agribusiness Department will forward any Protest Form which is duly signed (by an exhibitor as the protesting exhibitor, and if the exhibitor is a minor, the Protest Form must also be signed by the exhibitor's guardian or parent) and any accompanying materials submitted by the protesting exhibitor in support of the Protest to the Committee for its consideration. The Agribusiness Department will also notify the exhibitor being protested of the Protest as soon as reasonably practicable after the Protest has been duly submitted, and make available a copy of the written Protest to the exhibitor being protested. The exhibitor being protested may, but shall not be required to, provide a written response to the Protest (a "Response") by submitting a Response to the Agribusiness Department, including any materials in support of the response to the Protest, and the Agribusiness Department shall provide the Response to Committee. A Response shall be on a form obtained from the Agribusiness Department and must be signed by the protested exhibitor, and if the protested exhibitor is a minor, the Response must also be signed by the protested exhibitor's guardian or parent, unless the parent or guardian is not available due to circumstances that warrant, as determined by the Agribusiness Department in its sole discretion. The Agribusiness Department shall make available a copy of the Response to the protesting exhibitor upon request by the protesting exhibitor, but it shall be the protesting exhibitor's responsibility to monitor the Protest and to obtain a copy of the Response. The Agribusiness Department will attempt to notify the protesting exhibitor and the exhibitor being protested of the time of the Committee's review and consideration of the Protest by calling their respective cell phone numbers if provided on the Protest Form and/or the Response Form, but it shall be the protesting exhibitor and protested exhibitor's responsibility to monitor the Protest and obtain the time of the Committee's review and consideration of the Protest and to be available at the time scheduled for the Committee's consideration of the Protest. For any Late Submission, the Committee will handle the process for review of the Protest after the show.

- **3.** The Committee members present will review the Protest and the Response, if any, in the context of its rules and regulations and the IAFE National Code of Show Ring Ethics and will make a decision to resolve the Protest by a majority of the Committee members present. In the event of a tie vote, the Protest shall be deemed denied by the Committee. The decision of the Committee will be final.
- **4**. The Committee also may apply and enforce its rules and regulations and the IAFE National Code of Show Ring

Ethics, with respect to exhibitors at the show.

5. By entering the show, all exhibitors, and their Respective parents and/or guardians, shall be deemed to have acknowledged and accepted this General Disputes Policy.

ATTIRE

For showmanship and show, all exhibitors will be required to be clean, neat, and dressed according to the standards of the youth organization they are representing. FFA – Black jeans, white collared shirt, FFA Jacket, and Tie. 4-H – Black/dark jeans, white collared shirt, 4-H vest, jacket, and/or tie are strongly recommended. YLPA – Dark blue jeans, black collared shirt with logo patch. No caps or hats. Closed-toed shoes or boots are required. Exhibitors not conforming to the Dress Code will not be allowed to enter the show ring.

RELEASE

- 1. The first group of beef cattle will be released on Fri., Feb. 6^{th} from 7 p.m. to 9 p.m. All cattle must be out of the barns by 9 p.m., Friday.
- 2. The second group of beef cattle will be released on Monday, Feb. 9th at 7 p.m. All cattle must be out of the barns by 9 p.m.
- **3.** The third group of beef cattle will be released on Thurs, Feb. 12th from 7 p.m. to 9 p.m. All cattle must be out of the barn by 9 p.m. in order that preparations can be made for dairy animals arriving the next morning.
- 4. Consideration will be given to Open Out-of-State exhibitors & the different Zone levels for a Staggered Early Release. All arrangements must be coordinated with the Livestock Superintendent and exhibitors must have a Florida State Fair Release Form.
- **5**. No portion of the exhibit may be removed more than 2 hours before release time.
- **6.** Any exhibitor removing animals prior to release time forfeits rights to premium monies won.
- 7. TRAILERS WILL NOT BE ALLOWED OUT OF THE REMOTE LOT UNTIL DESIGNATED RELEASE TIMES.

1. There will be a dinner & meeting for all Beef Exhibitors on their respective week on Wednesday, Feb. 4th at 7 p.m., Saturday, Feb. 7th at 7 p.m., or Tuesday, Feb. 10th at 7 p.m. Tickets can be reserved by including \$12.00 per ticket with entry. The meal will consist of 2 meat entrées, two sides, a roll, a beverage, and dessert.



Also included are animals in the Percentage Charolais and Percentage Simmental (less than 50%) that do not qualify for their designated breed show.

- 4. A copy of the exhibitor's YQCA certificate must be mailed to the Agribusiness office on or before January 12, 2026.

RECORD BOOK - MANDATORY

- 1. PLEASE NOTE: The Fair will be collecting/judging ALL the Record Books prior to the Fair. Record Books must be postmarked or hand-delivered on or before January 12, 2026. Please note: you must turn in a completed record book to be eligible to compete in the Champion of Champions competition. NO RECORD BOOKS WILL BE ACCEPTED AT CHECK-IN. The completed record book must be approved and signed by the 4-H Club Leader, YLPA Representative, or Agriculture Teacher.
- 2. Non-registered animals will show in the All Other Youth Beef Cattle Show. Non-registered animals showing in the All Other Youth Beef Cattle Show MUST SUBMIT A COMPLETED RECORD BOOK TO PROVE PROOF OF POSSESSION. PLEASE NOTE: The Fair will be collecting/judging all the Record Books prior to the Fair. Record Books must be postmarked or hand-delivered on or before January 12, 2026. You must turn in a completed record book to be eligible to compete in the Champion of Champions competition. NO RECORD BOOKS WILL BE ACCEPTED AT CHECK-IN. Record books are available on the website.
- 3. Mail completed record books to Youth Beef Show, Florida State Fair, P.O. Box 11766, Tampa, Florida 33680.
- 4. An Online General Record Book is available at https://fsf.zsuite.org. Exhibitors are able to complete the record book online, however, they MUST still print it off for needed signatures and have it postmarked or hand-delivered on or before January 12, 2026.

A tutorial is available on our website on how to create an account and navigate the online record book.

- **5.** All Record Books will be scored on a basis of 0 100 and points will be added to Achievement Premium points.
- 6. A Record Book is mandatory in order to qualify for Champion of Champions Achievement Premiums. Exhibitors who do not turn in a record book will forfeit all Champion of Champions Achievement Premiums.

7. The Record Book will be returned by mail after the Fair.

RECORD BOOK SKILLS TEST - MANDATORY

- 1. Exhibitors will be given a Record Book Skills Test. The test will cover all aspects of record-keeping on their animal project.
- Juniors answer Junior designated questions. Intermediates answer Junior and Intermediate designated questions. Seniors answer Junior, intermediate and senior designated questions.
- 3. The Record Book Skills Test is mandatory in order to qualify for Champion of Champions Achievement Premiums. Exhibitors who do not take the test will forfeit all Champion of Champions Achievement Premiums.

SKILLATHON - MANDATORY

- 1. A Skillathon will be held in conjunction with the Record Book Skills Test.
- 2. The Skillathon is a series of "hands-on" stations where students will be asked to perform specific tasks.
- **3.** A Skillathon study guide is available on the website, at the seminar, or upon request.
- **4.** Junior exhibitors only need to do Junior level skills, Intermediate exhibitors only need to do Junior & Intermediate level skills. Senior exhibitors must do ALL level skills.
- 5. The Skillathon is mandatory in order to qualify for Champion of Champions Achievement Premiums. Exhibitors who do not participate in the Skillathon will forfeit all Champion of Champions Achievement Premiums.

EDUCATIONAL POSTER - Optional

Educational Poster may earn 30 points maximum.

- 1. Exhibitors can earn additional points toward Achievement Premiums by entering an Educational Poster.

- **9.** Posters must relate to the 2026 Skillathon topic of Health. Posters <u>are not</u> to be on showmanship.
- 10. Posters are not to be reused for another animal division in the current year or future years. Once the poster is judged/displayed it is disqualified for additional competition within the current year or future years. Posters are either photographed or marked submitted. The decision of the judge is final.
- 11. Other requirements:
 - a. Poster must have a title
 - b. Poster must have your name on the back and exhibitor's age as of September 1, 2025

- c. If the poster is a game/activity it must have instructions and an answer key **ON FRONT**.

YOUTH LIVESTOCK SHOW ETHICS AND ANIMAL CARE WORKSHOP

The Florida State Fair believes that every youth exhibitor should receive proper training and information for raising and showing a youth animal project. It is important that the exhibitor understand:

- The purpose of youth livestock projects
- The importance of ethics in youth livestock projects
- Proper animal handling and management
- The difference between animal welfare and animal rights
- Be prepared to be an ambassador for animal agriculture

The Youth Livestock Show Ethics and Animal Care Workshop is designed to certify students to meet the mandatory certification requirements that will be in effect for the 2026 Florida State Fair. Certification is

valid for three (3) Fair Seasons, not 3 calendar years.

For the 2025/2026 Fair Season, Certification Numbers starting with 24, 25, or 26 are current and valid.

The requirements are as follows:

ALL STUDENTS THAT ARE ENTERED IN THE FLORIDA STATE FAIR MUST HAVE COMPLETED THE ETHICS TRAINING TO SHOW AN ANIMAL AT THE 2026 FLORIDA STATE FAIR.

THE LAST WORKSHOP OFFERED FOR EXHIBITORS SHOWING AT THE 2026 FLORIDA STATE FAIR WILL BE ON JANUARY 19, 2026.

This program has been endorsed by the Florida Department of Agriculture and Consumer Services and the University of Florida, Institute of Food and Agriculture Sciences (IFAS).

**Please note: Even though you have attended an Ethics Workshop in the past, your certification number may have expired. Be sure to check your certification number to be sure it is still valid.

QUALITY ASSURANCE PROGRAM

The Florida State Fair believes that every animal participating in activities of the Florida State Fair shall at all times be provided proper care and management in the best interest of the animal's welfare.

- 1. Quality assurance testing or a survey may be done at the Florida State Fair.
- 2. All animals are subject to testing at any time:
 - **A.** To determine whether an animal qualifies for competition in a particular breed classification.
 - **B.** To determine whether the animal has been unethically fitted in any way.
 - C. To determine whether any false information or representation was made in a competition entry.
- **3.** Exhibitor's signature on Entry Form acknowledges that they have read and agree to IAFE Code of Show Ring Ethics, (Please note: Rule #4 deals specifically with drugs).
- **4.** Use of drugs, in animals, not in compliance with manufacturer's label as to dosage, time of withdrawal limitations, or other manufacturer's limitations and show regulations are **PROHIBITED**. The use of tranquilizers or possession of same after arrival at the Fair will be construed as tampering.
- 5. Violators will be disqualified and will forfeit all premiums and awards, including the sale price of animals, if applicable, and future entry of exhibitors and/or family at the Florida State Fair.
- **6.** The use of showing and/or handling practices or devices, using electrical contrivance, or other similar practices that are not recognized as acceptable training, restraint, or animal movement techniques are prohibited.

IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) NATIONAL CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open-class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations that they impose on the local, county, state, provincial, and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine

example. Owners, exhibitors, fitters, trainers, and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards, and auction proceeds and shall be prohibited from future exhibitions in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- **2.** Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
- Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- 4. Animals shall be presented to show events where they will enter the food chain free of drugs. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer, and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event that culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state, and provincial statutes, regulations, and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state, and provincial statutes, regulations, and rules affect the animal's performance or appearance at the event.

If the laboratory report on the chemical analysis of saliva, urine, blood, or other samples were taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample or urine, saliva, blood, or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved, and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise at any hearing in regard to the matter conducted by the fair or livestock show.

At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications shall be administered by a licensed veterinarian.

- 5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or irritant substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official shall be treated with courtesy, cooperation, and respect and no person shall direct abusive or threatening conduct toward them.
- 8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individuals to disciplinary action.
- **9.** The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
- 10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have any disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock

show. The act of entering an animal is the giving consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including *Fairs and Expositions* and any special notices to members.

11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action that contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

FLORIDA STATE FAIR AUTHORITY LIVESTOCK ADDENDUM

OWNER represents to Florida State Fair Authority ("AUTHORITY") that no animals that are exhibited or otherwise transported onto FLORIDA STATE FAIRGROUNDS will in any way be suffering from any contagious or infectious disease. In addition, OWNER shall defend, indemnify, and hold the AUTHORITY, the applicable Show Committee and each of their respective officials, officers, directors, employees and agents harmless of and from all losses, damages, claims, expenses, including reasonable attorney's fees at the trial and appellate levels, actions and causes of action arising out of, or in any way connected with, or by reason of this Agreement, the presence of OWNER's livestock at

FLORIDA STATE FAIRGROUNDS, and/or use of FLORIDA STATE FAIRGROUNDS including, but not limited to any claim for the death of, or injury to any person or livestock, or damage to, theft of, or destruction of any property arising out of any act or omission of OWNER, OWNER's officers, agents, employees, trainers, drivers, riders, handlers, contractors and livestock, violation of any Federal, State and Local environmental laws, rules, ordinances and/or regulations, actions for negligence, wrongful death, torts, defects in the real and personal property at FLORIDA STATE FAIRGROUNDS and from any alleged liability, cause, litigation or proceeding whatsoever, even if such injury, death, loss or property damage results, in whole or in part, from the negligence of AUTHORITY, or the applicable Show Committee and their respective officials, officers, directors, employees and agents or otherwise. Neither AUTHORITY nor such applicable Show Committee shall be liable to OWNER, or any officer, agents, employees, trainers, drivers, riders, handlers, or other contractors, invitees, or guests of OWNER for any injury or damage to livestock, person, or property. AUTHORITY, its officers, or agents, assume no liability for any loss or damage to property (including but not limited to livestock) on account of fire, theft, or any other cause including infectious or contagious diseases. In addition, OWNER acknowledges receiving and agrees to abide by the applicable rules and regulations of the AUTHORITY titled FLORIDA STATE FAIR LIVESTOCK RULES & PRIZE LIST, and the same are incorporated by reference herein.

a. Equipment

Video Camera, Camera with video ability

Microphone

Tripod

Lights

- b. Person to shoot the video
- c. Set-up of your video location

Small room - normal 8' ceiling height

Place your demo table in front of a blank wall

Place an easel/screen to one side

Make sure the light source is to the camera's back

d. Filming

Film at time without distracting noise, traffic, phone ringing, etc

Make sure your outfit is *official show attire* (required) and that it does not bleed into the wall color.

Straight shots: Introduction – middle and ending Overhead shots: Specific "how-to" in the middle

- -film overhead shots separately and edit into the main video
- -move the tripod to table and turn the camera looking down on the table; here you can shoot your hands putting items together and get a better video of what you are doing.
- e. Audio

A good video has an excellent audio. Types of microphones are

lavaliere (clip-on), **hand-held**, and **shotgun** (very long and attached to camera- very sensitive). Many cameras have audio, check if an external microphone such as a lavaliere can be used. Test your internal microphone before filming. If you can use an external microphone, a lavaliere microphone is suggested. It allows for movement as you demonstrate.

f. Lighting

Test the lighting in the room for a sample video shot. Will it wash out the speaker or cast shadows? Secure external lighting to highlight the speaker and table. The lighting should be parallel to the camera towards the film area.

4. Lights - Camera - ACTION

- a. Practice first before shooting
- b. After a few practice runs, now shoot a sample
- c. Review the video

Does it appear seamless?

How is the lighting? Are there problem areas to fix?

Is the audio clear and understandable?

Check the timing – are you within the limits?

Does the video flow well and is easy to follow?

- d. After fixing any parts of your demonstration, re-video
- e. When you are satisfied with your video, make sure you save it with your Title, Name, and Species.

All Other Youth Beef Cattle Show **Female Classification Information**

FOR THE 2026 FAIR: All Other Youth Beef Cattle Show Females will be shown in one of 2 shows: 1) AOB/Brahman Influenced Females or 2) AOB/Crossbred Females.

Upon entry, exhibitors will enter each animal in either the AOB/Brahman Influenced Female Show or the AOB/Crossbred Female Show, regardless if they are registered or commercial.


Brahman Influenced Female Show


The following criteria will be used to classify females in the Brahman Influenced show. Animals **MUST** meet 3 of the 5 criteria listed below:

- 1. ½ inch of hair or less
- 2. Ears are "broken" and come to a point
- 3. There must be an apparent crest
- 4. Navel score of a 2 or better
- 5. Dewlap must be prominent

Examples:







*If female does not meet 3 out of 5 of the above criteria, it will be entered in the Crossbred Female Show.

A committee will be present at the weigh-in to make sure females are in the correct show. This committee has the right to change females to the show they deem fit.
